Diet & Medication Requirements

On admission, the Owner is to comply with the following in respect of the dog.

1. Proof of immunization and current vaccination certificate must be shown on drop off. We also recommend the Leptospirosis vaccine.
2. DFS does not accept undersexed dogs over 6mths of age.
3. Hair should be clipped to allow for prevailing Doggy FarmStay (DFS) conditions, i.e. hair should be short, especially in tummy and leg areas;
4. Proof of immunization (C7) and vaccinations (current vaccination certificate) must be produced.

5. In the event that the dog requires veterinary attention and the Owner is not contactable, DFS may use its discretion in obtaining such veterinary attention as is deemed necessary and the Owner will be liable for or to reimburse the costs of such attention. DFS recommends that all owners arrange for appropriate pet insurance. In the event that medical care is required what is your financial limit?
6. The Owner acknowledges that DFS will take all reasonable care and precaution in the boarding of the dog but accepts no responsibility or liability for any injury, loss or damage that may be suffered by the dog while in its care. In particular but without limitation, the Owner expressly acknowledges that.
7. DFS allows dogs under its boarding care to exercise in secure, fenced outdoor paddocks but will not be held responsible for the escape of the dog through no willful or negligent act on its part nor for any injury, loss or damage caused by or to the dog as a result of such escape or exercise or from grass allergies, burrs, knotting, hot spots or grass seeds which might become embedded in paws;
8. DFS will not be held responsible for snake bites, ticks, Paralysis Tick, Canine Influenza or similar illness or condition contracted by the dog.
9. Any bedding, collars, tags and/or coats are left at the Owner's risk and DFS does not assume any responsibility for the safe return of any such items.
10. Boarding rates and charges are calculated on a calendar-day basis.

11. All charges and expenses incurred must be paid by the Owner prior to collection of the dog. Pending payment, DFS may exercise a lien over the dog including further boarding charges incurred.

12. In the event that the dog is not collected by the due date (or any agreed extension of that date) and boarding charges and expenses incurred have not been paid within 14 days after that date, DFS may sell or otherwise dispose of the dog at its discretion with all costs incurred to be for the additional account of the Owner and any moneys received to be applied towards the account.

13. DFS takes all care with your dog/s but is not responsible for any injuries incurred whilst in the care of Doggy Farm Stay, including but not limited to any joint injuries, cuts, abrasions, ligament damage, tears from playing etc.

14. It is expected that the Owner will dutifully inform DFS of any issues, medical or emotional, that the dog has or has had in the past.

15. The Owner declares and confirms that their dog is social and behaves well with other dogs when in an off-lead environment such as a park or similar and has not been involved in any significant fights and/or has not been declared a dangerous dog in any state or territory of Australia.

16 . Medication Administration Disclaimer:

I understand and agree that Doggy Farmstay Pty Ltd will administer medication only according to written instructions I provide. I acknowledge that all medication has been prescribed or recommended by a licensed veterinarian. I release Doggy Farmstay Pty Ltd, its owners, and staff from liability for any adverse reactions or outcomes.

In the event of a medical emergency, DFS may seek veterinary care at my expense.
